Keith had a discussion with Dr. Hank Hays, Regional Director for TAHC, in which Dr. Hays indicated that TLBAA was one of the few breed organizations that continues to require results from TB and Brucellosis tests be recorded on health certificates for animals entering TLBAA events. The veterinarian suggested we consider eliminating these tests from our event requirements. Much discussion ensued about the animal health requirements for different states and the possible consequences of not having TB or Brucellosis status when transferring animals between states.

Russell Fairchild gave a brief update on the progress of the Horn Showcase.
