### Horn Showcase Proposal (Additional Item to Agenda)

Keith received a notice that the Horn Showcase committee "is proposing the Horn Showcase be held in Duncan, OK, this year and would like our approval. The dates are November 3-6, 2022."

➤ A motion was made by David Wars, and seconded by Sandi Nordhausen, that the Horn Showcase be held in Duncan, OK, on November 3 – 6, 2022. The motion passed with no opposition.

## TLBT Advisory Committee (Agenda Item 3)

Keith suggested that the board create guidelines for the TLBT Advisory Panel. The guidelines should cover how the advisors are elected, term length, board liaison, etc. Currently the youth select the advisors.

➤ A motion was made by David Wars, and seconded by Kevin Rooker, that the board appoint Keith DuBose as liaison to meet with the TLBT Board of Directors and the TLBT Advisors and have them create guidelines (operating procedures, committee descriptions) and submit those to the TLBAA Board of Directors for approval. The motion passed with no opposition.

#### **TLBT Showmanship Proposal (Agenda Item 4)**

The World Show committee submitted a proposal to allow show chairmen to put the TLBT Showmanship classes wherever they prefer in the show order. Wording in the current rule states that an exhibitor and an animal must have been shown (*past tense*) in a show class in order to be eligible for the showmanship class. This implies that the showmanship class must come at the end of the show. Some affiliate show chairmen, and some exhibitors, would like to conduct the showmanship classes at the beginning of the show. The proposal would allow, but not mandate, the show chairman to schedule the showmanship classes in any part of the show.

➤ A motion was made by David Wars, and seconded by Deb Lesyk, to leave the Minutes recorded by Stephen Head Page 1 of 3

showmanship rule as it currently is written. The motion passed. Stephen Head was the only opposition.

Many directors expressed the opinion that showmanship should reward the exhibitor who can work through the day and persevere.
